Online Access User Agreement and Disclosure Statement

This Online Access Service Agreement (this “Agreement”) is made as of _____, 2____ (“Effective Date”), by and between MG Trust Company, LLC (“MG Trust”), having an address at 700 17th Street, Suite 300, Denver, Colorado 80202 and _____ (“Plan Sponsor”) for _____ (name of plan or trust), having an address at _____.

1. **Definitions:**

Authorized User means a trustee, Plan Sponsor, or employee or agent of Plan Sponsor who is authorized by Plan Sponsor and MG Trust to access the MG Trust Plan Sponsor Website solely for internal business purposes.

2. **Services Provided:** MG Trust agrees to provide Authorized Users access to view and print specified account holdings and transaction information for Plan Sponsor’s accounts via a customized website. MG Trust agrees to grant Authorized User a non-exclusive non-transferable access to the Custom Designed Website solely for the limited purpose of providing access to Plan Sponsor’s account information. Nothing herein shall give any ownership rights to the Custom Designed Website. The Website is the sole property of MG Trust and Innovest Systems, LLC.

3. **Accessing the Service:** Authorized User shall have access to the website only via a protected Password mechanism. The Password granted to Authorized Users is unique to each user and may not be shared with other users, whether authorized or non-authorized. Passwords shall be provided only by MG Trust. The Plan Sponsor shall be solely responsible for requesting MG Trust to provide a Password to be used by Authorized Users. Plan Sponsor shall be solely responsible for the protection of such Passwords to ensure that only Authorized Users access the Website. Plan Sponsor shall ensure that all Authorized Users comply with the terms and conditions of this agreement, and shall be solely responsible for any failure by the Authorized Users to do so. Because the provided Password can be used to access sensitive account information, all Authorized Users should treat the Password with the same degree of care and confidentiality that they use to protect other sensitive financial data. All Authorized Users agree to not give the Password, or make it available, to any person not authorized to access the website. Further, Plan Sponsor agrees to notify MG Trust immediately, should any previously authorized user become ineligible for access, so that the password may be deactivated.

4. **Limitation of Liability:** MG Trust is not responsible for any loss, injury, or damage, whether direct, indirect, special, consequential, exemplary, economic, or otherwise, caused by the use of the Website or the unauthorized access of the Website.

5. **Exclusions of Warranties:** You agree that we are providing the Website access on an “as is” basis without any warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability and fitness for a particular purpose.

6. **Assignment:** You may not assign this Agreement, or any of your rights or responsibilities under this Agreement to any other party. We may assign the Agreement or any or all of our rights and/or responsibilities under this Agreement or delegate any or all of such rights and responsibilities to any third party or parties.

7. **Fees:** In consideration of the services to be performed by MG Trust hereunder, the Plan Sponsor shall pay MG Trust an annual fee of \$100. This fee is waived for plans that pay an annual service fee for custodial or trustee services.
